1. To be allowed for exportation to China, feed and feed additives excluded from the list must complete the market entry procedures, the registrations of overseas production and processing enterprises in accordance with regulations in *Measures for Inspection, Quarantine, Supervision and Administration of Imported and Exported Feed and Feed Additives*.

2. As for the feed and feed additives with import permit, before the completion of the registration of overseas production and processing enterprises, importation may continue as usual; After the completion of the registration, only the importation from the registered production and processing enterprises is permitted.

3. For unprocessed gains for processing feed, please see relevant regulations of inspection and quarantine for imported unprocessed gain.

4. Since January 1, 2013, imported feed raw materials shall provide the *Registration Certificate of Imported Feed and Feed Additives Products (Copy)* in accordance with the Announcement No. 1773 of Ministry of Agriculture of PRC, when applying for the *Permit for the Quarantine of Entry Animals and Plants* and the import quarantine inspection.

5. Pet food that contains animal-derived ingredients shall comply with regulations of *Catalogue of Prohibited Animals and Their Products Imported from Country/Region of Epizooty*.

6. In accordance with the latest risk analysis result and Announcement No. 1773 of Ministry of Agriculture of PRC, feeding cocoa shell is prohibited from importing.

7. Since January 8, 2014, the office paused to accept or approve the *Permit for the Quarantine of Entry Animals and Plants* concerning the processing of plant-derived protein feed product of Pakistan, Vietnam, Russia, Kazakhstan and Canada (where rapeseed dregs is permitted). The permit previously accepted and approved continues to be valid before the deadline.

8. The export trade of alfalfa from Sudan to China is newly added.

9. The export trade of fish meal and fish oil from Mauritania to China is newly added.

10. The export trade of beet pulp from the United States to China is newly added.

11. The export trade of natural forage grass from Mongolia to China is newly added.

12. The export trade of rapeseed dregs from Pakistan to China is newly added.

13. The export trade of beet pulp from Ukraine to China is newly added.

14. The list of registered producing and processing enterprises for swine blood protein and hydrolyzed poultry feathers protein from Spain to China is newly added.

15. The export trade of wheat bran from Kazakhstan to China is newly added.

16. Because the processed vegetable protein products of some countries have made no real trade in recent years, in order to ensure the quality safety of imported goods, related products shall be deleted, according to relevant regulations.

17. The export trade of feeding dried porcine soluble from Netherlands to China is newly added.
