## ABOUT THE PROGRAM

October 13, 2020, marks 50 years of diplomatic relations between Canada and China. A diplomatic relationship between two countries of disparate size, culture, and political systems will inevitably have ups and downs, but the history of Canada-China relations did not begin in 1970, and it will continue for decades to come. As we approach this milestone anniversary, we reflect on how Canada has benefited from its relationship with China, and in so many cases, these benefits were the result of individual efforts. The relationship is really about people. People who had the forethought to establish relations when China was still in the midst of the Cultural Revolution. People who forged institutional and business ties. People who fought to demonstrate their country's values in the course of developing relationships. People who spent time learning the other country's language and culture. People who valued the other country's opportunities so much that they made their homes, lives, and careers in the other country.

CCBC's *5 at 50* initiative will recognize individuals in five categories who helped Canada benefit over these 50 years. A panel of arbiters will assess nominations and will choose up to 10 finalists and 1 recipient in each category, including:

- Immigrants
- Alumni
- Entrepreneurs
- Women
- Relationship Builders

CCBC will work with organizations across Canada to broadly solicit nominations and disseminate the stories of these individuals. One person in each category will be featured during CCBC's AGM event on October 13, 2020, and finalists will be highlighted through a social media campaign.

## NOMINATION GUIDE

To nominate an individual, please submit the following:

- Nomination form
- A description of how this individual helped Canada benefit from the diplomatic relationship with China between 1970-2020 in a chosen category (one page max, 12-point font, single-spaced)
- A brief bio or CV of the individual (one page max, 12-point font, single-spaced)
- A high-resolution professional photo of the nominee (if available)

You may nominate more than one person, but please use separate nomination sheets for each nomination. We also accept self-nomination.

Eligibility:

- Nomination is open to any individual with an accomplishment in the chosen category; CCBC membership is not required.
- The nominator or his/her business must not be the subject of any legal investigation.
- The nominee or his/her business must not be the subject of any legal investigation.
- Submissions found to contain false information will be automatically disqualified.
- Submissions exceeding the stated length will not be read by the judges.
- Nominees must be living.
- In keeping with CCBC award tradition, individuals recognized as *40th Anniversary Honourees* in CCBC's 2018 awards process are not eligible for this year's *5 at 50* initiative.

## NOMINATION PROCEDURE

- Nominator or self-nominee must send the Nomination Form and supporting documentation by **Friday, September 11, 2020**, by email to Aude-Alexia Veronneau, [events@ccbc.com](mailto:events@ccbc.com).
- Send all documents in PDF format except the nominee's photo (high-resolution jpg or png preferred).
- Finalists will be notified in advance.
- Finalists may be required to submit additional information for further consideration and clarification.
- Winners will be announced on October 13, 2020, at CCBC's AGM, which is planned to be held in a hybrid virtual/physical format.
- The decision of the Judging Panel is final.
